KINGSLEY METHODIST EPISCOPAL CHURCH AND CEMETERY

As promised in our last Newsletter, we are pleased to print the names and dates found on the gravestones in the Kingsley Methodist Episcopal Church Cemetery on Route 552 in Chester. It is a tranquil spot, approximately 1½ acres in size, enhanced by the presence of four majestic oaks and one hickory tree, all over 100 years old.

Our thanks to Miss Catherine Kirwan and Mr. Walter Coppage who were kind enough to brave last summer's heat to record the information. In addition, we are pleased to print the exact text from a newspaper clipping saved by Miss Kirwan's grandfather, the late Senator James E. Kirwan, of the dedication of the Kingsley Church as it appeared in the Centreville paper at that time. It appeared as follows:

"CHURCH DEDICATION ON KENT ISLAND 1886

The dedication of Kingsley Methodist Episcopal Church took place on Sunday. November 28th. Rev. J. B. Quigg of Smyrna, preached at 10:30 A.M., Rev. J. A. Arters at 3 P.M. and Rev. Mr. Quiga again at night. The church was filled to its utmost capacity at all three of the services. Rev. Mr. Quigg managed the finances assisted by Mr. Arters, J. B. Bright, J. E. Kirwan, and the pastor. Seven hundred and thirty five dollars were needed to cover the indebtedness of the church and \$745 was realized in cash and subscriptions. The church was dedicated at the close of the night service by Rev. Mr. Quigg assisted by Rev. Arters and Rev. A. D. Dick of the M. P. Church and the pastor. The choir of the Stevensville M. E. Church with Miss Ella Quinn, organist, had charge of the music. We had a good day, good congregations, good preaching, good singing, and good giving and as a result the occasion was a grand success. The people of Crab Alley Neck now have the most commodious and as attractive a church as is to be found on the Island, costing less than \$2,000. Many thanks to the friends of the other churches of the Island for their financial assistance."
