Minutes

In addition to finalizing Kent Island Days, these other topics were brought up for discussion. Vice President Nick Hoxter (who was filling in for President Hugo Gemignani) informed us that members from local organizations have been organized to select/vote for colors, mascot, etc. for the new Stevensville High School. He then told us no one from the Heritage Society or the Stevensville High School Alumni Association was mentioned as being present on the Board. He said he spoke to Sonny Schulz about taking care of getting the Alumni Association represented and he would talk to the Heritage Society about our involvement. Nick asked for input from Heritage members, and all thought both the Alumni Association and the Heritage Society should be allowed to participate in the decisions. Nick said he's handle it from there.

Nick also informed us of a zoning hearing he attended. There is a proposal in front of the county to build another body shop by the old Stevensville High School. A medical/office complex has already been approved by the county to be built across the road from the old High School site. This complex would take on "the look" of the old buildings and old Stevensville. Nick, as vice president in representation of the Heritage Society, said we do not approve of building the auto body shop. He informed the meeting attendants that is it against the law to build on grave sites/cemeteries; and that it is believed that there is a cemetery on the proposed location of the body shop. The attorney and inspectors present at the meeting were not aware of this and informed their client (Duty's Body Shop) that this poses problems and may even halt the project. Before the project approval came to a vote, it was also mentioned that this area should be dedicated as a historic district. A vote was then called for, the motion was passed, and they're going to go ahead with the construction of another body shop. Nick suggested we contact Mike Foster and see what if anything we can do. Bill Denny made the motion to talk to Mike to get his advice; and if Mike proposes going forward with stopping the project, then we should. Eva Thompson seconded it. The vote was unanimous. Nick asked Billy to call Mike, and he agreed.
